# AMENDMENT OF DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS AND RESTRICTIONS FOR CROFTON HEIGHTS HOMEOWNERS' ASSOCIATION

WHEREAS the original of Declaration of Protective Covenants, Conditions and Restrictions for Crofton Heights Homeowners' Association was duly recorded with King County on December 8, 1988, under King County Auditor's File No. 8812080878; and

WHEREAS Article VI, Subsection 6.1 thereof, required that the Declaration could be amended by an affirmative vote of not less than 75% of the lots; and

WHEREAS in excess of 75% of the owners of lots agreed in writing by their signatures affixed to that certain document entitled Exhibit "A" attached hereto and incorporated herein by reference, to amend Article III, Subsection 3.7, as more fully set forth in Exhibit "A"; and

WHEREAS in excess of 75% of the owners of lots agreed in writing by their signatures affixed to that certain document identified as Exhibit "B" attached hereto and incorporated herein by reference, to amend the language relating to amendment of the Declaration of Protective Covenants, Conditions and Restrictions for Crofton Heights as more fully set forth in Exhibit "B" attached hereto.

NOW, THEREFORE, the Declaration of Protective Covenants, Conditions and Restrictions for Crofton Heights is amended as set forth on Exhibits "A" and "B" attached hereto.

#### Article III

3.7 Fences. No fence, wall or hedge shall be erected or placed on any Lot nearer to any street than the minimum building setback line, except that nothing shall prevent the erection of a necessary retaining wall, the top of which does not extend more that two feet above the finished grade at the back of said wall. Fences bordering green belt areas shall be of stained cedar or redwood, not to exceed six feet in height, with finished side facing green belt areas. No chain link fencing shall be visible from any street or green belt area. All fences shall be per the ACC approved standard fence design.

Proposed Addition.

Exception for chain link fence may be made for the park area bordered by 256th street providing that the Board of Directors furnish an estimate of cost of erecting said fence and receive approval from a majority of homeowner's.

In the event that the required 75% of owners fail to respond to written notification of an amendment vote by attendance at a homeowner's meeting or by written proxy vote, the unrepresented votes will be counted as if they had voted with the majority.
